The Colloquium will include 60, 90 and 180 minute Institutes or Workshops, 30-minute Research Sessions, Roundtable Discussions and Posters.

If you were accepted for a **60, 90 or 180-minute Institute or Workshop**, your presentation will take place on Tuesday, Wednesday, Thursday, or Friday.

If you were accepted for a **30-minute Research Session**, your presentation will take place on Wednesday or Thursday. Each research presentation will be scheduled with one or two other research presentations during a 60 or 90 minute time block. Each research presenter or team of presenters will have 30 minutes to present their work.

If you were accepted for a **Roundtable Discussion group**, your session will take place on Thursday. During a 60-minute block of time 6-8 information/discussion roundtables will be held simultaneously in the hotel ballroom. Each presenter or team of presenters will have 60 minutes to share information/lead discussion with a group of 10-15 participants around their topic. **There will be no av equipment available for these information/discussion roundtables, but handouts are encouraged.**

If you were accepted for a **Poster presentation**, your materials will be displayed during the Welcome Reception on Wednesday evening from 5:30 – 6:30 pm. Additional information on the poster set up will be provided.

Lead presenters of accepted abstracts are entitled to the special discounted Colloquium registration rate of \$275 for members and \$325 for non-members. **To receive the discounted presenter rate please register by April 1, 2022**. All presenters must register for the Colloquium and are responsible for their own travel and lodging expenses.

Handouts should be submitted by May 15, 2022. Handouts will be made available to registered participants through the APSAC website as pdf files. Any files not submitted as pdf files will be converted. Hardcopies of the handouts will not be distributed at the Colloquium.

All workshop and research presentation rooms will have a podium microphone, screen and projector. These items do not need to be requested. Presenters using PowerPoint, videos or other media as part of their presentation are asked to bring their own laptop computer.
